8. System improvements

All personnel develop operational systems to be efficient, fast, modern, convenient. and provide opportunities for stakeholders and service users to participate in the improvement Improving operations to create attitudes and good confidence to service recipients.

9. Information Disclosure

All personnel make up-to-date information on the agency openly or on its website for the public. Acknowledgment to show that management is transparent and verifiable

10. Fraud prevention

All personnel follow anti-corruption measures. act according to the direction of Intent in administration with honesty, transparency, good governance can check and promote culture. Organization to be an organization in the virtuous zone leading to the honest zone.

11. No gift policy

All personnel do not accept gifts and gifts of any kind. to strengthen culture and values Integrity
